Adoption Application and Agreement

I,, make the above statements truthfully and
voluntarily enter into this agreement to permanently adopt and care for this animal from
Tumbleweed Cat Rescue (TCR). Additionally, I agree:
• That I am over 18 years of age.
• To provide a TCR representative access to all parts of my home for a home inspection, if
needed, before my application is approved.
• Cats are to live in a private residence as companion animals, unless otherwise agreed as
follows:
• To provide the cat with sufficient quantities of nutritious food, wet and dry, as appropriate,
fresh water, and scooped litter daily.
• Never to physically or verbally "punish" the cat. I understand cats do not learn from this.
 Never to have the cat declawed or otherwise cosmetically altered.
• To ensure that the cat's vaccinations for rabies and distemper are current and to provide timel
veterinary care upon any sign of sickness, disease, or injury.
· To abide by the registration and animal ownership laws of my city of residence, and to registe
the microchip information, as applicable, within 14 days of adoption. I will contact TCR within
24 hours if I lose the animal so they can assist in publicizing and help my search.
• To give the original caregiver visitation rights to ensure that the terms of this adoption
agreement are being observed and that TCR representatives may contact me for follow-ups.
• If the cat must be relinquished for any reason, I will make a good faith effort to locate and
contact Tumbleweed Cat Rescue.
• I will not transfer possession or custody of my adopted animal to any other person at any time
unless given permission from a TCR representative.
• I understand that failure to perform the foregoing agreement will constitute a breach of
contract. In the event of any such breach of contract, I authorize the original caregiver to
reclaim possession of the adopted cat.
• TCR makes no warranty as to the pet's temperament or physical condition. The pet is being
adopted as is. Any known medical records will be provided within 7 days of adoption. If an
animal is not the right fit for my family, I will notify TCR as soon as possible and discuss
options with them, and any concerns I am having.
• To release TCR, and its representatives, volunteers, and board members, from liability for
personal injury, property damage, legal fees, veterinary care, any other expense, or liability
incurred by me, others in my residence, or anyone with which I allow contact with my adopted
animal, as a result of this adoption. I agree to indemnify TCR from any and all such claims an
to pay, without limitation, any costs related to such injury, damage, or liability, including, in
the case of litigation, any attorneys' fees incurred by TCR in its defense.
